The Shirley Proctor Puller Foundation provides safe, reliable, accessible out-of-school-time programming to black and multi-race K-8th graders in the at-risk community of South St. Petersburg.

SPPF's M.A.S.T.R. Kids (Math, Art, Science, Technology and Reading) intervention model has produced robust evidence of achievement gap progress and closure. Each year since inception, 70-80% of students attending the summer program have avoided the "summer slide." During the 2021-2022 school year, SPPF served 190 unduplicated students. Of the students who attended the program with fidelity, 28% were reading at grade level in July 2022 vs. 8% in August 2021. Student demographics are as follows:

57% female/43% Male
